Vice Commander Responsibilities and Expectations:

1. Visit all of your assigned Posts' membership meetings at least once during the year. It might not be 100% possible but do your best to get to them. If there is a Post that you won't be able to make it to during the year, let the Commander, another Vice Commander or the Membership Director know so that one of us can make a visit. I would like every Post to be able to say that they were visited by a District officer this year.
2. At the Mid Winter Conference and the District Convention, have a report prepared to give on your activities with your Posts. Visits, events, how you have assisted them, what they have asked for assistance with, the good things happening in Posts, the bitches, moans and complaints you are hearing whether it's about Post, District, Department or National.
3. Assist Posts with their issues to the best of your ability. We (The District) don't get involved with bar, kitchen, gambling or club business or invited to do so by the Post membership. The Post business and the business regarding their bar, kitchen, gambling and club business are two separate issues. It's our job to promote the programs of the American Legion and to assist Posts if they have questions about how to start or expand programs within Posts. We do what we can to assist with membership issues.
4. If you are not able to assist a Post with the questions they have or are not sure how to assist them, pass those questions and issues along to the Commander or to the appropriate person in the District. We handle issues at the lowest level possible. There really should never be a reason that anyone has to go directly to Department or National. Use the "chain of command."
